Background: Robert Carswell McGinty, 87, of Toombsboro passed away Saturday, Sept. 6 in Macon. Son of the late Truman & Essie Saunders McGinty, he was born in McRae and made his home in Wilkinson County. Mr. McGinty served as Toombsboro City Clerk and on the Wilkinson County Board of Education. He joined the Wilkinson County Bank in 1941 as Bookkeeper, was elected to the Board of Directors in 1951, promoted to Executive Vice President in 1966, and elected President in 1970, where he served until his retirement in 1988. He remained on the Board of Directors until 2004, having never missed a meeting during his 53 years of service. Mr. McGinty is preceded in death by his brother, Jack E. McGinty. Mr. McGinty was a WWII Veteran, having served in the U.S. Army. He enjoyed working in the yard as well as fellowship and meals at Herb's Fish House.
